# **DIRECTIONS FOR USE:**

Product should be mixed at a rate of 1 pound per 1 gallon of warm water unless stated otherwise. Mix to form a slurry and let sit for 30 minutes before pouring mixture into water to be treated.

## **SEPTIC SYSTEMS:**

Use 1 pound of product for each 400 gallons of capacity purge dose. If the drain field is clogged with grease, use United 556 ZYME-TREAT WWT feeding 6 gallons of product per each splitter box.

For continued maintenance, use 10% of the purge dose per month. No additional United 556 ZYME-TREAT WWT is needed unless field clogs with grease again.

# **HOLDING TANKS AND LIFT STATIONS:**

**Initial Treatment:** Use 2.5 pounds of product per 100,000 gallons.

**Note:** This product is not designed to add on top of a grease cap in a lift station. It must be added directly to water.

## **SANITARY AND STORM SEWERS:**

To break down cellulosic buildup in lines mix 0.25 pounds per 6 gallons of warm water. Let sit for 30 minutes before adding to the line.
